Amount of condensate to be imported and rate of goods manufactured from the condensate must be approved from BPC before importation d. Should take a certificate from a minimum of director grade officer of BPC stating that ""Condensate is being imported solely for use in the importer's own plant during its operational period"""	Article 25(16) of Import Policy Order 2021-2024 [Bangla]
