3	Production and expiry date shall be clearly embossed on each container or package; not on the container or package by labelling it separately. Expired food items cannot be imported.	Article 23(19), IPO 2021-24 [Bangla]
4	If preservatives, additives and colours are used in preserved food, its label and details shall be embossed on the container, label not to be pasted separately.	Article 23(21), IPO 2021-24 [Bangla]
